HOW WE CAN REMOVE A DANGEROUS PRESIDENT – LEGALLY AND CONSTITUTIONALLY

WHY THIS MATTERS

THE U.S. CONSTITUTION GIVES US THE TOOLS
TO REMOVE A PRESIDENT WHO ENDANGERS OUR
DEMOCRACY — BUT IT'S NOT AUTOMATIC.
IT REQUIRES ACTION BY ELECTED LEADERS AND
PRESSURE FROM THE PEOPLE.

HERE'S HOW IT WORKS.



1. Impeachment & Removal

What It Is: A constitutional process to hold presidents accountable for **abuse of power, criminal behavior, or betrayal of the public trust.**

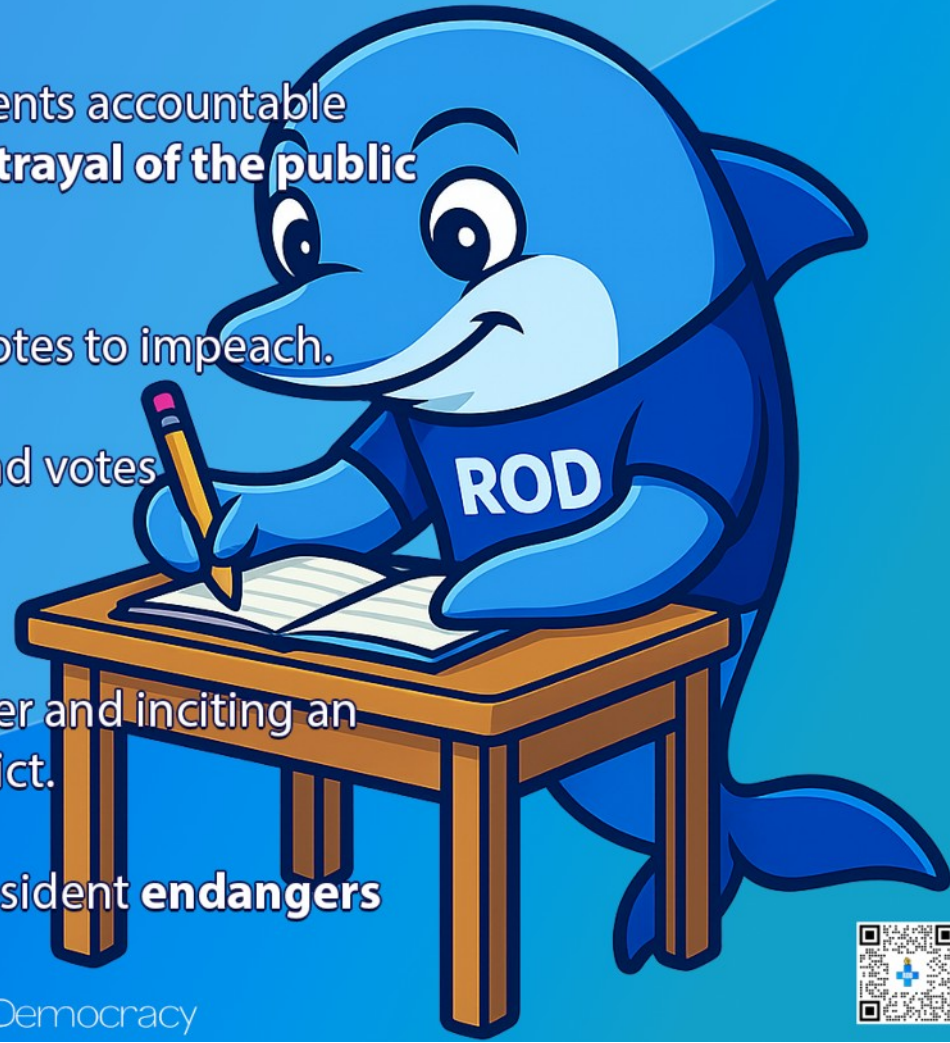
Who Can Start It: The House of Representatives votes to impeach.

Who Decides Removal: The Senate holds a trial and votes (2/3 majority required).

Used Before:

-Trump was impeached twice — for abuse of power and inciting an insurrection — but the Senate failed to convict.

Our Role: Demand that **Congress act** when a president **endangers lives, democracy, or national security.**



2. 14th Amendment, Section 3 – The Insurrection Clause

What It Says: Anyone who swore an oath to the Constitution and then engaged in insurrection or rebellion is banned from office.

Applies To: Presidents, Members of Congress, Cabinet officials — anyone who attacked democracy from within.

Used Today: Legal challenges argue Trump's role in January 6th qualifies. Some states tried to remove him from ballots, but the Supreme Court blocked states from enforcing it unilaterally.

Our Role: Support legal efforts and **push** Congress (or vote them out) to pass enforcement legislation.



3. 25th Amendment – Incapacity & Unfitness

What It Does: Allows removal if a president is **mentally** or physically unable to serve.

Who Acts: The Vice President and a majority of the Cabinet.

If Contested: Congress must vote to remove (2/3 in both chambers).

Why It Matters: Designed for emergencies — including presidents who are **unstable, delusional, or dangerous**.
(See our tariffs history since he took office, lack of air traffic controllers and his own references to being a King.)

Our Role: Raise public awareness. **Call on leaders to act** when the president becomes a threat to the nation's wellbeing.





Other Tools to Protect Democracy

Elections: The fastest, most direct way to remove a dangerous leader is not re-electing them.

Congressional Oversight & Censure: Pressuring lawmakers to investigate and hold power accountable.

Criminal Investigations: DOJ and state attorneys general can pursue charges before or after a president's term.





What You Can Do Now

Know your power: *NO ONE is above the Constitution.*

Stay informed: *Share this info widely.*

Organize & vote: *Authoritarians fall when people rise together.*
